## What is payroll giving?

Payroll giving lets you donate to the causes you care about straight from your pay. Since donations are taken directly from before tax, it means BeyondAutism receives more of your donation and it costs you less!

### Payroll giving is a really tax effective way to donate

For every £1.00 that you give it will only cost you 80p, and if you're a higher rate tax payer it will only cost you 60p. Your donation will come out of your salary before tax but after National Insurance meaning it will cost you less.
